II. Who is not guilty 8:6b~8:9 誰是無罪的

a. List of sins 罪的目錄

* Source of sin : Satan (8:44) 罪的來源: 撒旦

* Sins (Chap. 8) : adultery (8:3) Murder (8:37, 44) Lie (8:44) 罪: 姦淫, 殺人, 說謊言

* Price of Sin: Death (8:24) 罪的代價: 死

* Control by Sin : Slaves of Sin (8:34~35)

被罪控制: 罪的奴隸

* Who does not have sin: Lord (8:9, 34-36)

誰沒有罪: 主耶穌

* Who can judge: Lord (8:11) 誰能審判: 主耶穌

* Who can forgive sin: Lord (8:11)

誰能赦免罪: 主耶穌

* Who can free people from sin: Lord (8:31, 36)

誰能使人脫離罪: 主耶穌

b. Qualification of Executioner

執行者的資格

約翰 John 8:7b: If anyone of you is without sin, let him be the first to throw a stone at her.

「你們中間誰是沒有罪的，誰就可以先拿石頭打他。」

III. Who can convict sinner and who can forgive sin? 8:10~11 誰能定人有罪、誰能赦罪?

a. No one was eligible to convict the woman.

沒有人有資格定那女人有罪

約翰 John 8:10: Where are they, has no one condemned you? 那些人在那裡呢? 沒有人定你的罪嗎?

b. Jesus did not convict the woman either.

耶穌七也沒有定那女人有罪

約翰 John 8:11: Then neither do I condemn you....Go now and leave your life of sin. 我也不定你的罪。去吧, 從此不要再犯罪了!
